


Infosec Toolkit for Election Volunteering

From federal data breaches to foreign governments phishing political campaigns to malware shutting down city services, our nation is under attack. You can help – starting right in your own community. Local and state officials are working to build a more resilient electoral process, but their capacity is limited. They need civic-minded infosec professionals to combine their knowledge and talents as technical volunteers for Election Day and beyond. The information below will help you understand the election process and provide tips on how you can get involved.

Volunteer Roles

Volunteers come from all parts of the community. They are typically as diverse as the community in which they live, but share the common belief that voting is a right that everyone should be able to exercise with confidence.

Requirements for Vetting Volunteers

Volunteering for elections requires some planning and understanding that volunteers will be vetted and trained to ensure a smooth election process. Below are some of the considerations that you should be aware of:

- Register to vote in your jurisdiction
- Basic background check
- Professional reference
- Available for 1-day training 6-8 weeks prior to Election Day
